#### 1. Listing date:

The indicators 'NSE Listing date of equity shares' and 'BSE Listing date of equity shares' have been added in 'Identity Indicators' Query Trigger of ProwessIQ. These indicators will give you the date on which the company's shares were listed for trading on the National Stock Exchange and Bombay Stock Exchange.

#### 2. Company/Issuer not co-operating filter added in the 'Credit Ratings' Query Trigger:


